April 4, 2018
6:00 P.M. Reorganizational Meeting

The North Attleborough School Committee met on Wednesday, April 4, 2018 at 6:00 p.m. in the James M. Rice Conference Room at the Woodcock Administration Building.

Committee members present included: James McKenna, Kathryn Hobbs, Gary Lake, Kevin O'Donnell, Adam Scanlon, and Carol Wagner. Ethan Hamilton was absent and accessed the meeting remotely.

Superintendent Scott Holcomb, Assistant Superintendent Lori McEwen, Business Administrator David Flynn, and Director of Facilities and Grounds Kyle Kummer represented Central Administration.

Superintendent Scott Holcomb called the meeting to order at 6:00 p.m. The Pledge of Allegiance followed. Mr. Holcomb explained that Committee Member, Ethan Hamilton was absent and would be participating in the meeting remotely. A sound check was performed to confirm connectivity.

Superintendent Holcomb thanked Mr. Neal Gouck for the 9 years of service he provided to the North Attleborough Public School system as a member of the School Committee. Mr. Holcomb proceeded to congratulate and welcome newly elected member, Kathryn Hobbs.

Superintendent Holcomb then asked for nominations for the Chair of the School Committee for the 2018-2019 year. Kevin O'Donnell nominated James McKenna as Chair and Gary Lake seconded. No other nominations were presented and no discussion ensued. Mr. Holcomb requested a role call vote. So voted: Adam Scanlon – Yes, Kathryn Hobbs – Yes, Gary Lake – Yes, Carol Wagner – Yes, James McKenna – Abstained, Kevin O'Donnell – Yes, Ethan Hamilton – Yes. Passed 6-0-1.

The gavel was passed to Chairman McKenna. Mr. McKenna then asked for nominations of Secretary to the School Committee. Carol Wagner nominated Kevin O'Donnell as Secretary and Ethan Hamilton seconded. No discussion. Chairman McKenna then asked if there were any other nominations. Gary Lake nominated Adam Scanlon as Secretary and Adam Scanlon seconded. No discussion. At this time, Mr. McKenna requested a role call vote on the first nomination of Kevin O'Donnell. So voted: Ethan Hamilton – Yes, Kevin O'Donnell – Yes, James McKenna – Yes, Carol Wagner – Yes, Gary Lake – No, Kathryn Hobbs – Abstained, Adam Scanlon – No. Passed 4-2-1. Chairman McKenna stated that since this vote passed, there was no need to vote for the second nomination.

Chairman McKenna asked Committee members to contact him regarding their preferences for subcommittees and the meeting was adjourned at 6:05 p.m.
